Potholes, Roads and Roadblocks A message from Mayor Valerie Burd

If you live in the United City of Yorkville and you've driven down our streets lately, you probably have a pothole story you could share with me. For me to write that this has been a bad winter for streets is an understatement.

The City's Director of Public Works, **Eric Dhuse,** tells me these potholes, some of which residents describe as being the size of small lakes, are the direct result of the multiple freezing and thawing episodes that we have had this winter.

"When water gets down into cracks in the road surface, and then freezes, it expands those cracks and the pavement crumbles," Eric says. "With multiple snows, thaws, and then deep freezing, it has made it a very hard winter for our streets."

Eric also mentioned that the 30+ snow events we've lived through this winter haven't helped our streets' pavement. "Four thousand pounds of steel snow plows sliding across roads can do a lot of damage," Eric says.

Combine this winter's woes with construction on Van Emmon Road and the already crumbling condition of streets like McHugh and Fox, and it is obvious that the city has some major repair work in our future. Eric assures me that his crew are out on the streets daily, applying cold patch to potholes and cracks, and they have budgeted for 150

tons of hot patch, which they will begin applying in early April, after the asphalt plants reopen for this year. The streets highest on the list include Fox, State, Spring, Woodworth, Park and Freemont.

Van Emmon, which was torn up to install a water main, is already being cold patched, but no permanent fix will be accomplished until individual hookups are made to homes that front on this road. Those hookups should be completed in April, with the final



repair to that road following soon after. As someone who lives only a block off of Van Emmon and who travels down that road often, I am exasperated at the fact that such a recently repaved street had to be torn up and that drivers have had to travel down what basically became a one-lane road for so many weeks. Part of the reason for this state of affairs, I am told by City Engineer Joe Wywrot, is that in this older part of the city, utilities had been put in under the street.

"Normally, these utilities are in the parkways," Joe says. "In all our newer developments, we require that they be placed in the parkways, but in this area, we have a narrow right of way." We also have older utilities, some dating back to the 1930s and even before. So, whenever work has to be done on these older utilities or on any of the utilities, streets have to be torn up. It negatively impacts the city's ability to use tax dollars wisely in repavement projects in this area, but the utilities need to be maintained. In this instance, the developer of Kendallwood Estates will be paying to repave the torn up section of the road.

Last year, the city completed Phase 2 of our **InTown Road Program**. Because the original scope of that project, which improved streets and utilities in the downtown area, *(continued on page 2)*

did not include a comprehensive plan to handle stormwater runoff in properties adjacent to the street, we had a large number of complaints about flooding and fear of flooding during construction.

After a special City Council meeting I called last summer to address those concerns, more than \$40,000 in change orders alleviated those problems identified at the meeting. Residents are reporting little or no flooding, even with the heavy snow we've experienced this winter. The construction delay caused by the meeting resulted in \$20,000 in change orders, but I believe it was a necessary expense, needed to address homeowners' concerns.

Unfortunately, despite the need for street improvement, the city cannot budget this year for Phase 3 of the InTown Road Program. Although streets have been identified, a way to fund the \$6 million needed to do the work has not been found. I had hoped to use 25 percent of sales tax revenue from new commercial development, like Kohls and Home Depot, to fund street improvements, but for this year at least, that will have to be put on hold as the money is needed to make up sales tax and building permit revenue lost because of the down

turn in the housing market. Despite having to keep a sharp eye on our finances, the city has budgeted this year to repave sections of McHugh Street between Walnut and Spring Streets, and Palmer Court. and it will be continuing the Asphalt Surface Treatment Program on Countryside Parkway, in streets near the Jewel Store, in Fox Industrial Park and in Raintree Unit 1. This program involves applying liquid asphalt to roadways to make the pavement more impervious to water and more flexible so that it will crack less.

The city also is continuing to plan for a major roadway improvement to Game Farm Road, which now is scheduled to commence in early 2010. Joe Wywrot says the project has been somewhat delayed by the need to purchase easements. "It's a big project," he says, "and it requires extensive engineering."

When completed, the new roadway will have three lanes, including a center turn lane and left turn bays at Routes 34 and 47. The Illinois Department of Transportation, which is overseeing this project, is also working on engineering for the future



widening of Rt. 34 through Yorkville.

Finally, to address one of Yorkville's major roadway concerns, the widening of Rt. 47: Gov. Blagojevich's recent appointment of our former Congressman Dennis Hastert to a special committee to compile a list of Illinois projects to be part of a massive new Capital Bill may be the impetus that will finally get Rt. 47 widened. The committee, which also includes the president of Southern Illinois University, has been charged with deciding which school and infrastructure improvements throughout the state are the most needed projects.

I believe Rt. 47's time has finally come.

CFLs radiate a different light spectrum from that of incandescent lamps, but improved phosphor formulations have improved the subjective color of the light emitted by CFLs.

City's dog ordinance helps to keep our parks clean and safe!

The United City of Yorkville would like to remind all residents that the city has an ordinance regarding dogs in place to help keep people and animals safe, our city clean, and neighbors happy.

According to the ordinance dogs must be:

- Confined by a fence of sufficient height and security (which may be an electronic invisible fence system) to prevent the animal from leaving the area so encompassed;
- On a leash under the control of a responsible person;
- On a leash securely fastened to an inanimate object and of a length which prevents it from leaving the property of its owner or keeper;
- Any dog found upon a pulic street, sidewalk, alley or any unenclosed place, shall be deemed running at large unless the dog is firmly held on a leash or is in an enclosed vehicle.

It shall be unlawful for any owner to allow a dog to defecate on private property, without permission of the property owners, or any public street, sidewalk or park without properly disposing of such waste in a trash receptacle.

Public Works News

From the Water Department

The United City of Yorkville utility bills (water, sewer maintenance, garbage and wastewater treatment) are sent to every residential and business unit within the city limits on the first day of the following months: January, March, May, July, September, and November. Fox Metro bills wastewater treatment for the Grande Reserve subdivision.

Water meter reads are taken at the beginning of each month and billed at the end of each month. For example, reads taken at the beginning of October will be billed on October 31 for August and September water usage.

Due to the lag time in the meter reading/billing process, if you move you will need to call for a final meter reading. Also, please note that if you do not receive your bill you can obtain your balance and due date information by calling City Hall at 630.553.4350.

Senior Citizen Discount Rate:

A qualified senior citizen (age 65 or older) bimonthly refuse fee is \$1 for a single-family or duplex unit per utility billing cycle. Proof of age is required. For information, call 630.553.4350.

Yorkville Bristol Sanitary District Charges (YBSD):

The United City of Yorkville bills and collects the YBSD "user charges" for wastewater treatment.

To meet stricter standards mandated by the Illinois Environmental Protection Agency (IEPA), and to provide service to the area, the YBSD has borrowed \$9 million from the state of Illinois' Revolving Loan Program. Loan monies pay for the expansion of the wastewater treatment plant located at 304 River Street. The YBSD also has an existing debt incurred in 1991 of \$3.5 million. The dedicated source of revenue format is a requirement of the IEPA to assure the low-interest loan is paid back over a 20-year period.

The "user charges" are as follows: \$1.10 per 100 Cu. Ft. of flow, providing that the user pay a minimum bimonthly fee of \$76.11 of which \$25.45 is dedicated to debt service for the repayment of the IEPA Act Loan. The debt service is \$25.45 and \$50.66 is for operation and maintenance. The total is \$76.11. Please note: If a customer uses 6,920 or more cubic feet of water, the fee would be calculated at \$1.10 per 100 cubic feet.

Utility Billing Rates

The minimum utility bill for a two month period is \$127.91. For senior citizens the two month minimum utility bill is \$107.05.

Water Rates:

Bimonthly minimum charge: Up to 350 Cu. Ft. \$11.94; \$2.17 per 100 Cu. Ft.* thereafter

Sewer Maintenance Fee:

Residential, commercial, industrial, and government fees are \$18/60 days per unit

Refuse Fee:

The refuse fee is \$21.86/60 days per single-family or duplex unit

Senior Discount Refuse Fee:

The senior discount rate is \$1/60 days per single family or duplex unit (age 65 years of age or older required)

Yorkville-Bristol Sanitary District (YBSD):

Residential, commercial, industrial, and government (treatment of wastewater)-6,919 Cu. Ft.: \$76.11 minimum fee. Over 6,919 Cu. Ft.: \$1.10 per 100 Cu. Ft.* Also, please note that 1 Cubic Foot equals 7.48 gallons.

The YBSD does not discount for pool filling or watering. The flat fee of \$76.11 is for up to 6,919 Cubic feet. Any usage over 6,919 will be billed at \$1.10 per Cu. Ft.

Grande Reserve Utility Billing:

Grande Reserve residents are billed the same charges for water, sewer, and refuse as all other Yorkville residents. The



difference is that Fox Metro is the sanitary district for Grande Reserve and does their own utility billing from reads provided to them from the meter reads that are conducted by the United City of Yorkville. The rates are as follows: \$5.25 minimum for 350 Cu. Ft. usage then \$2 per 1,000 gallons (134 Cu. Ft.). For example: 1,000 Cu. Ft. usage equals \$15.

A minimum utility bill from the United of Yorkville to seniors 65 years of age or older is \$30.94 (this does not include Fox Metro Sanitary charges).

The Fox Metro Sanitary District billing for filling pools and watering sod that services Grande Reserve is as follows:

 Fox Metro will adjust the bill if you have either filled a pool or watered new sod. This is not an automatic adjustment.

1. By Mail

You can mail your bill by the payment date to the United City of Yorkville at 800 Game Farm Road, Yorkville, IL 60560.

2. Walk In

You can walk into the City Hall offices between 8 a.m.-4:30 p.m. before the payment date and pay your bill by cash or check at 800 Game Farm Road, Yorkville, IL.

3. Drop Box

An after hours drop box is available for your convenience. The box is located under the flagpole before you enter City Hall. Bills should be dropped off at your convenience before the payment date.

4. Direct Debit Payment

Direct debit payment is auto-deducted from your checking or savings account on the day the bill is due. Applications are available at City Hall or on the city's Web site at www.yorkville.il.us. Completed forms can be dropped off or mailed to City Hall: Attn: Judy Dyon, Utility Billing Clerk, UCOY, 800 Game Farm Road, Yorkville, IL 60560.

5. E-Pay

This internet payment program is available through the State of Illinois to Yorkville residents. Payments can be made with a variety of credit cards including Visa, MasterCard, American Express, Discover and E-check. A user fee of \$3.50 per transaction is added to the payment amount for the convenience of Internet service; however, this fee is not charged or collected by the city.

Veolia Environmental Services Refuse Information

The United City of Yorkville contracts refuse service with Veolia Environmental Services. The current refuse rate is \$10.93 per month. The senior citizen discount is .50 cents per month (\$1 per billing cycle).

Under the city's refuse agreement with Veolia Environmental Services, each residence is allowed to put out one 65-gallon Veolia refuse cart (green), one 65-gallon recycling cart (blue), and one large household item on the regular pick up day only (such as a couch, chair, or mattress) to be collected weekly without a pre-paid sticker. Carts are provided by Veolia. Residents may exchange their 65-gallon refuse cart at an additional cost of

\$5 per month billed directly to the residents by Veolia.

Additional refuse containers may not exceed 32-gallons in size or 50 pounds in weight. Carpeting is considered a bulk item, however it must be cut and rolled into 4-foot lengths. Each roll must be tied and not weigh more than 50 lbs. Up to 4 bulk rolls will be accepted as one bulk item. Construction materials, large automotive parts, tires, white goods, hazardous wastes and materials from floods, fires, and evictions will not be accepted during weekly collection.

All refuse should be place out for collection by 6 a.m. on your designated collection day. Veolia Environmental Services have co-collect trucks that accommodate both refuse and recycling items and are not combining recycling with refuse.

A \$1 pre-paid sticker is required for each bag or 32-gallon container outside the cart. Pre-paid refuse stickers are sold at the following locations: Ace Hardware, 9620 Rt. 34; Jewel-Osco, 234 Veterans Parkway; Pride Pantry, 302 Bridge Street; and at the United City of Yorkville, City Hall, 800 Game Farm Road.

Refuse service will be delayed one day following New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving and Christmas.




Spring pick up schedules

Yard waste pick up

Yard waste in the United City of Yorkville is collected from April 1 through November 28. Stickers are not required for yard waste. In order to be collected the waste must be put in brown kraft bags. Please note that sod will not be collected.

Brush pick up

The United City of Yorkville provides brush pick up from April through October. Brush must be placed parallel to the curb in neat stacks no longer than six feet in length and no wider than three inches in diameter. Brush must be placed on the parkway no later than 7 a.m., Monday morning. Brush crews will not return for special pick ups once your street is completed. Brush will not be picked up again until the next scheduled date for your area. Please note the the pick up schedule listed.



Brush pick up (north of the river) April 21-25; June 23-27; Aug. 25-29 and Oct. 27-31

Brush pick up (south of the river)
May 26-30; July 21-25; Sept. 22-26 and

White goods pick up

White goods pick up in the United City of Yorkville is scheduled for the week of April 14-18 on your regular pick up day only. Items need to be placed on the curb by 6 a.m. Only one pass will be made. White good items include refrigerators, freezers, water heaters, air conditioners, humidifiers, stoves, clothes dryers and washers, microwaves, dishwashers, heat pumps and furnaces. If you have questions regarding a white good item, please contact Veolia at 630.587.8282.

Hydrant Flushing

The city's Public Works Department schedules hydrant flushing for the months of April and October. If you experience rust in your water during this process, please let your water run clear and use caution when doing laundry on days that hydrant flushing is scheduled. In the event that rust does occur, *Rust Remover* is available at local hardware stores. The April schedule is listed below.

Street Sweeping

The city's Public Works Department has announced tentative dates for street sweeping. Please note that the dates listed below are tentative and may vary slightly depending on weather conditions.

Water Conservation Ordinance goes into effect...

Help us conserve our natural resources. Our Water Conservation ordinance is effective from May 1 through Sept. 30.

The ordinance for outside water usage permits landscape watering and pool filling between the hours of 5 a.m. and 9 a.m. and/or 9 p.m. and midnight. Water may be used for landscape watering or the filling of swimming pools as follows:

- All properties with even-numbered street addresses may water only on even-numbered calendar dates during permitted hours of water usage.
- All properties with odd-numbered street address may use water only on odd-numbered calendar dates during permitted hours of water usage.

There is no restriction on the watering of flowers, shrubs, trees and gardens using a handheld hose or watering device. Also permitted, is a handheld watering device when filling pools containing 50 gallons of water or less, the automatic watering of trees and shrubs by means of an automatic root-feed or drip-irrigation system and vehicle and equipment washing.

Please be aware that if you violate the provisions of the ordinance you will be fined \$50 for the first offense, \$125 for a second offense and \$500 for each subsequent offense.

A sod watering permit is required for any resident watering between May 1 and June 30 and September 1 - September 30. Permits may be obtained at City Hall, 800 Game Farm Road between the hours of 8 a.m.-4:30 p.m. Monday through Friday. Call Public Works at 630.553.4370 for information.

Public Works News

City's water compliant with IEPA standards.

The United City of Yorkville is now radium compliant and has been for the past year. As mandated by the IEPA, we are required to print the information listed below. If you have a question, please call the city's Public Works Department at 630.553.4370.

Our Public Works Department routinely monitors for the presence of drinking water contaminant. Quarterly samples taken over the past year show that our system is compliant for gross alpha combined radium. The standards for gross alpha is 15 pico curies per liter (pCiL) and 5 pico curies of combined radium. The average level of gross alpha was 33 pCiL, and combined radium in the past years was 19 pCil per liter.

Q. What should I do? You do not need to use an alternative (e.g. bottled water) supply. However, if you have specific health concerns, consult your doctor.

Q. What happened? What is being done? The United City of Yorkville has designed and constructed Ion Exchange facilities, which will remove the radium below the 5 pico curies per liter level. All three treatment plants are currently online.

Please share this information with other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

From the Department of Building and Safety

pring is coming and as the warm weather approaches, the Department of Building Safety would like to remind residents that the United City of Yorkville inspects and enforces property maintenance codes.

These codes help to maintain property values and standards. Please check and use the following list of possible violations of the 2000 International Property Maintenance Codes, which has been adopted by the city of Yorkville to evaluate your own property.

- Grass should be kept to 8 inches or less in height (Ordinance No. 2008-5)
- Trees and hedges should be trimmed along sidewalks so that pedestrian traffic is not obstructed.
- Garbage should be properly disposed of in approved containers.
- Be sure to keep areas clean of stagnant water where mosquitoes could breed.
- Dispose of junk and rubbish from yards. This could include auto parts, appliances, furniture, tires, etc.
- No inoperative or unlicensed motor vehicle shall be parked or kept on any premises, and no vehicle shall at any time be in a state of disrepair.
- Be sure to have your address numbers placed where it can be visible from the street or road fronting the property.

A brief reminder...As summer approaches, the United City of Yorkville is reminding all residents to comply with the city's adoption of the 2000 International Residential Building Code that requires a permit for above ground pools that are capable of containing 24 inches or more of water. Kendall County Planning Consortium Update

The fourth meeting of Kendall County Planning Consortium was held on Jan. 24 at the Yorkville Public Library. Thirty-six individuals attended including representatives from the United City of Yorkville, Village of Lisbon, Village of Millbrook, Village of Minooka, Village of Montgomery, Village of Oswego, City of Plano, Village of Plattville, Village of Big Rock, and Kendall County.

The topic for discussion was historic preservation with presentations given by **Mike Ward**, coordinator of Local Government Services for the Illinois Historic Preservation Agency, and **Stephenie Todd**, historic home specialist out of Aurora.

Mike Ward gave an overview of the federal, state, and local legislative roles in historic preservation. Historic preservation began at the federal and state level in 1966 allowing a building, place, and/or landmark to be listed on the federal historic preservation registry, if it has historic and cultural significance to the entire country, or on the state historic preservation registry, if its significance is to the State of Illinois. Local historic preservation, established in 1980, allows communities to establish local historic preservation agencies and preservation ordinances to protect places of historic and cultural significance to the community.

Stephenie Todd gave a presentation on Aurora's historic preservation efforts. The city of Aurora has numerous historic districts in which exterior changes to the buildings are governed by the local preservation ordinance. She showed examples of historic homes which had been rehabbed and preserved due to the local preservation ordinance along with the help of grant funding provided by the city of Aurora.

Kendall County Planning Consortium meetings are held on the third Thursday evening every other month. The next meeting will be held May 15 (proposed) with a presentation to be determined. ATM SAFETY TIPS BEWARE OF THIS ATM SCAM!

There are a lot of ATM scams out there, but you need to beware! Use the following guidelines below when using an ATM machine:

- Try to use machines you are familiar with, and use terminals located in banks rather than independent terminals.
- Be aware of your surroundings.
 Look around before completing a transaction.
- If you must use an ATM after hours, make sure it is well lit.
- Shred your ATM receipts when you no longer need them.

As a reminder, please use caution when you are removing large sums of money from any ATM machine.

PROJECT CHILDSAFE

The Yorkville Police Department is currently participating in the **Project ChildSafe Program.** This program's primary purpose is to provide gun owners with safety locks. The locks are free to the owners.

It is the belief of the Yorkville Police Department that this type of prevention is necessary. The Police Department endorses this extremely important program.

This simple procedure of placing a cable through the working mechanism of a gun and locking it can save a life of a curious child or adult who is not familiar or comfortable with guns. By doing this, it does not preclude the owner to keep the gun in a safe place out of reach of a child or from a potential theft. TORNADOS 101 Be prepared!

With spring approaching, households should prepare for storms and the possibility of severe weather, including tornados.

When conditions are favorable for severe weather to develop, a severe thunderstorm or tornado WATCH is issued. Weather Service personnel use information from weather radar, spotters, and other sources to issue severe thunderstorm and tornado WARN-INGS for areas where severe weather is imminent. Severe thunderstorm and tornado warnings are passed to local radio and television stations and are broadcast over local NOAA Weather Radio stations serving the warned areas. These warnings are also relayed to local emergency management and public safety officials who can activate local warning systems to alert communities. If a tornado warn ing is issued for your area or the sky becomes threatening, move to your pre-designated place of safety.

What about the sirens in town? Below are guidelines to the two types of weather sirens we have in the United City of Yorkville - weather/civil warning sirens and lightning detection sirens.

WEATHER WARNING SIRENS

Q. When do the sirens go off?

- •The first Tuesday of each month at 10 a.m. the weather warning sirens are tested.
- •The weather warning sirens are activated for severe weather based on information received from the National Weather Service. Kendall County ESDA activates the sirens for such emergencies.

Q. What does it mean?

•When the sirens go off for weatherbased emergencies, it means to seek shelter and follow precautions for tornados.

Q. Is there an all-clear siren?

Kendall County does not issue an all-clear siren after severe weather has passed. Make sure you have a battery-operated radio and listen to the local radio stations for updated information. DO NOT CALL 9-1-1 for this information.

LIGHTNING DETECTION SIRENS

Q. What are these?

•These are sirens that are located at most parks and schools that have fields used for outdoor sport activities.

Q. What does it mean?

- •If you hear one, long blast, it means to seek shelter indoors and take precautions for weather with lightning involved
- •If you hear three shorter blasts, it means the immediate threat of lightning has passed...it does not mean more isn't on the way!!

These sirens are meant to aid coaches and adults in keeping children safe. They are machines, and are not 100 percent accurate. Adults should continue to use their judgment in making sure it is safe to hold games and let children play on open fields.
