Yorkville's Mayor explains recent water rate increases

We are working through a bad recession. People who have lost jobs or whose homes have been foreclosed know things are bad. Money is tight and unfortunately, these hard times are also hitting your City government.

In 2004-06, the City issued bonds to extend water and sewer lines for new construction, and to pay for removing radium from our water, something that was mandated, but not paid for, by the State of Illinois. Many of the homes were never built, because of the recession. As a result, the City did not get the anticipated revenue in to make the payment on these bonds, beginning in 2009. At the beginning of this fiscal year, the City was \$1 million in deficit in our Water Fund and we were looking at a \$1.8 million deficit by the end of the fiscal year.

The Water Fund is an enterprise fund. It is supposed to be completely self-sufficient, based on revenue coming in from tap-on fees paid for by new residents, and from our water bill payments. Cuts were made in the department that operates water services, but it wasn't possible to cut enough to eliminate the deficit to make the bond payments. To meet the City's obligations, the City Council voted on May 25 to increase your water rate by 5 percent to \$12.54 up to 350 cubic feet of usage, and to apply an \$8.25 infrastructure surcharge per month until April 30, 2011. It was not something that any of the members of the City Council wanted to do. No one could come up with any other solution.

The City Administrator has estimated that if there are 200 tap-on fees coming into

the City this fiscal year, we can abolish the surcharge. That is why the Council is open to discussing extending the freeze that Pulte was given in 2005 on building fees, when the economy was still going strong. Consequently, if building stops because Pulte can't compete, the City won't get any fees. One hundred percent of nothing is nothing. The freeze was also extended for Crestview Builders, which purchased the Blackberry Oaks development. (Continued on page 11)

U.S. Census Bureau names Kendall County fastest growing in the country

Kendall County was once again named the fastest growing county in the United States, according to an article that appeared on CNNMoney.com in June.

The **U.S. Census Bureau** states that Kendall County grew nearly 100 percent in the last nine years. The county went from a population of 54,563 on April 1, 2000, to an estimated 104,821 last July 1.

The article says that one of the reasons for the boom during the nine year time period was the county's transition from an agricultural area to a bedroom community. Sixty percent of the 300-square-mile county is still zoned for agriculture.

However, the population growth has slowed since the economic downturn to 3.3 percent from July 1, 2008 to July 1, 2009.

First, I am being contacted by residents regarding flooding in many of the developments and communities throughout Yorkville. If you feel that your property is flooding as a result of a poor drainage design or inadequate stormwater runoff mitigation, please contact your alderman.

The Council has also recently voted to raise your water rates, impose an amusement tax on businesses, and institute an infrastructure fee to your water bills of \$8.25 per billing cycle starting July 1 in order to pay for bonds due to be paid for capital projects. A few aldermen voted against these increases in fees and taxes, and furthermore stated that they did not feel it was the right time or economy for these measures to be taken. Once again, those aldermen were in the minority. Therefore, you will see all instituted and by now have likely to have seen these increases and fees on your current water bills.

Our City is starting to sporadically see some requests from builders and developers to resume pulling permits and building homes. It is my belief that this growth should be controlled, as we have been burned by developers in the past who have not paid their fees and debts.

GREEN TEEN AWARD WINNER TAYLOR COFFEY

On Tuesday, June 22, Mayor Valerie Burd and the United City of Yorkville City Council honored Yorkville High School graduating senior Taylor Coffey with the first-ever Green Teen award.

The city's Green Committee recommended Coffey for the commendation because of his dedication and commitment to educate other teens through Yorkville High's **Students Acting For the Environment (S.A.F.E.)** Club.

The Green Committee also recognized Coffee in May during the school's Honors Night.

Coffey said he was surprised to receive the award. "It was quite an honor to receive it (the Green Teen award) in front of my peers, some of whom were not aware of my efforts in the school," Coffey said. "My parents were just as shocked and were very proud. It was very nice to be recognized, because I honestly did not think anyone even noticed what I had done."

But many people did notice the difference that his efforts were making including the city's Green Committee and many of his fellow club members.

His progression in making a difference, he admits, was slow. He joined S.A.F.E. as a sophomore but on a limited basis. In his junior year, Coffey became more active since he was able to drive, and made a conscious decision to attend more meetings and organize a few of the club's events. At the end of his junior year he was appointed as the group's vice president and ran the club during his senior year.

"One of the first things I suggested to the group was to have a fundraiser," Coffey said. "We decided that we would promote the use of reusable water bottles by selling them at school. Unfortunately, the school board denied our request due to the fact that the water bottles were not clear."

At that point, Coffey said, the group's enthusiasm was low, so he decided to organize an education committee. "The goal of the education committee was to advertise

both the mission of S.A.F.E. and to promote environmentalism around the school," Coffey commented.

To ensure the committee's goal would be met, the group designed billboards and posters promoting environmentalism that were hung in classrooms and the school's corridors. "We even decided to add another officer position to the club to head the education committee," Coffey said.

According to Coffey, the primary reason that the S.A.F.E. Club existed was because of the school's recycling program. "The club has always been responsible for going around each Friday afternoon to collect the paper recycling bins," Coffey said.

But this year, the school's administration made a decision to expand the recycling program to include all recyclable materials.

To keep S.A.F.E. members involved and engaged Coffey organized small events throughout the year including the clearing of invasive honeysuckle behind Yorkville High, creating bird feeders and giving them as gifts to members of Yorkville's senior community, helping to clean and refurbish parts of the Hoover Forest Preserve, and organizing and coordinating Earth Week events to commemorate the 40th anniversary of Earth Day.

"The best part of Earth Week was the cafeteria staff revealing that it would be switching to reusable food trays, as opposed to Styrofoam," Coffey said excitedly.

Coffey will be attending **Loyola University in Chicago** in the fall and will study biology and psychology with plans to share his education with others.

Yorkville receives grant funds to add recycling cans to city parks

The United City of Yorkville has received a grant from the Illinois Department of Commerce and Economic Opportunity to purchase recycling cans to be placed in the City's parks.

The City received \$5,897 to expand recycling collection in Yorkville's parks to capture additional recyclable commodities. The City will be responsible for \$787.79, with a total cost of \$6,684.79.

Twenty parks throughout the City will receive a large 32-gallon waste receptacle for disposing of recyclable items. These cans will be placed adjacent to the trash cans and will be clearly labeled for recycling of paper, plastics, and metals.

The City is required to collect these recyclables and report on the tonnage of material diverted from the waste stream. Without designated recycling cans, currently all of the trash ends up in landfills. A large amount of paper, metals, and especially plastics from water bottles and sports drinks can now be separated from the waste stream and recycled.

These recycling cans are made from post-consumer recycled plastic lumber with each pound of lumber containing eight to 10 recycled milk jugs.

Scott Sleezer, Yorkville's superintendent of Parks, anticipates that the new recycling cans will be in the parks by the end of August.

Yorkville's **Civil Engineer, Jackie Dearborn,** says that,
"Recycling is about more than just the environmental benefits. It also benefits the economy by creating jobs throughout the state."

Kudos to both the **Green Committee** and Dearborn who have boosted Yorkville's efforts to recycle, reduce, and reuse in our community.

Dearborn submitted the grant application on behalf of the City's Green Committee.

Council Amends City's Burning Ordinance

On June 8 the **United City of Yorkville City Council** amended the city's burning ordinance as follows:

- 1. The open or outside burning of any materials, including plastic coated, treated paper, paper materials, leaves or plant materials within the City limits is expressly prohibited.
- 2. Burning of campfires in connection with camping outings by organized groups; or recreational campfires by individuals are permitted, provided that the fires are conducted in such a manner so as to constitute a hazard or nuisance to persons or property.
- 3. Untreated paper, paper products, untreated wood, stumps, and logs may be burned provided; a. Such burning is not conducted within 20 feet of any neighboring building or structure; b. Such burning is continuously controlled and supervised by an adult with adequate fire suppression devices immediately available.

All campfires shall be extinguished properly to avoid any reigniting; c. Such fires shall be contained within an adequate fixture or suitable retention device so as to prevent ambers from carrying to neighboring properties; and d. Wind conditions do not exceed 10 miles per hour.

- 4. The discharge into the outdoor atmosphere of fumes, smoke, gas or vapors or any combination from the burning of any materials other than untreated paper and paper products and wood as provided above shall be, for the purposes of this section, declared air pollution and a public nuisance.
- 5. Controlled fires started and attended to by the personnel of the United City of Yorkville in order to control the growth of prairie grass or other vegetation to benefit the public health, safety or welfare shall be permitted.



Mailbox Replacement Policy

Only mailboxes that are struck directly by a City vehicle or piece of equipment will be eligible for replacement. Damage caused by snow is not eligible. Below are a list of procedures to follow if your mailbox is damaged by a City vehicle.

- •You must notify the **Public Works Department** within three days of the incident. A temporary mailbox will be installed until it is determined if the City is responsible.
- •A Public Works representative will inspect your mailbox and determine if it was properly installed, the material was in good condition, and if it was struck by a City vehicle.
- •If it determined that the City is responsible, the homeowner is eligible for reimbursement of up to \$75 for replacement
- •Reimbursement may be submitted to the City after the homeowner installs a new mailbox and it is inspected by a Public Works representative.
- •The homeowner is responsible for the replacement of the mailbox in all instances when the City was not at fault. To report an incident call Public Works at 630.553.4370.

Pedestrian safety reminders from the Yorkville Police Department

The **Yorkville Police Department** would like to remind residents to

keep their sidewalks clear of obstructions. In addition to Yorkville's local ordinance stating that, "no person, on any sidewalk shall do any unnecessary act or thing thereon so as to obstruct its free and quiet use and passage" (5-3-2-4), Illinois law also prohibits "the stopping, standing or parking of vehicles on sidewalks. [625 ILCS 5/11-1303(a)(1)(b)]

Pedestrians use sidewalks for taking the family pet for a walk, recreational walking or going for an early morning run. Vehicles parked over the sidewalk often force people to walk out into the street to get around them.

According to Yorkville's Police **Chief Rich Hart,** vehicles parking over sidewalks are an important public safety concern.

"As recent as last year we had an elderly person break a hip while walking around a vehicle that was blocking a sidewalk," Hart said.

The Police Department's ultimate goal is to provide for safe pedestrian traffic in accordance with state and local laws.

"Parking over the sidewalk tickets are not a money maker for the City," Hart said. "We write very few tickets for parking over a sidewalk and most of the tickets issued are generated from citizen complaints."

Hart also asks that residents keep their sidewalks clear of toys, lawn equipment and other items that can interfere with pedestrian right-of-way.

"In the winter accumulated snow and ice can become hazards as well," Hart added. "Please take a moment each day to make sure the sidewalk in front of your residence is clear. Your neighbors will appreciate your efforts."

Vehicle owners violating this law are typically issued an ordinance citation with a fine of \$25.

Also...Please remember even though school is out of session there are many pedestrians walking to festivals, riding bikes and walking for recreation this summer. Illinois state law mandates that you must yield to a pedestrian in a crosswalk when driving a motorized vehicle. Please help us keep our visitors and residents safe!! Thank you!

Attorney General Lisa Madigan's Silver Beat Educational Awareness Program

Attorney General Lisa Madigan created the Silver Beat Educational Training Program to ensure that seniors, as well as all age groups, have the knowledge and tools needed to guard themselves from con artists and deceptive business practices.

Last year there were over 31,000 consumer fraud complaints with a tremendous increase in debt settlement and identity theft.

Typically in spring, law enforcement agencies and the Attorney General's office are flooded with the popular home repair fraud scams where people go door-to-door throughout an entire neighborhood and offer to repair roofs or sealcoat driveways at a minimum cost. These

people typically ask for and receive a deposit and they never return to complete the work.

One of the newest rapidly increasing scam is called "spoofing". A spoofing card device purchased on the Internet results in spoofing fishing that allows a con artist to falsify the phone number displayed on an individual's caller ID. With this spoofing device, the call appears to come from a legitimate source.

Some con artists have gone to the extreme of spoofing the contact information of a state or federal government agency to deceive consumers. The con artists also leave messages on answering machines requesting a return call. Unfortunately, individuals verify their caller ID information and return the call

believing it is a legitimate business or government agency.

The purpose of spoofing is to obtain personal information such as social security numbers, date of birth, maiden names and other personal information that would lead to identity theft.

Another rapidly growing scam is the "Grandparents Scam." Scam artists claiming to be attorneys, paralegals or law enforcement officers frantically call a senior citizen saying that a grandchild is in trouble and requests the grandparent immediately wire a large sum of money to assist their grandchild.

Upon investigation by the attorney general's office, it appears the seniors are targeted by family member information appearing on **Facebook** pages and/or in obituaries.

If the recession hadn't hit, these developments probably would have been completed. It makes sense to me to encourage them to go ahead and finish what was started, so that we don't have as many vacant lots that need to be maintained, and so that new residents can help alleviate the burden of the bond payments for infrastructure improvements.

The City Council also recently implemented a 3 percent amusement tax, to go into effect on Oct. 1.

Raging Waves already had agreed in an annexation agreement to pay a 5 percent tax. The new tax will be levied on services, such as bowling or pool,

that are not currently taxed—30 cents on every \$10. The City of Oswego recently raised its sales tax one percent across the board on all businesses. The amusement tax is less invasive, and an average 50 percent of it will be paid by people coming into our community from the outside, instead of entirely by our residents. This tax will not be levied on food in restaurants, or on any other service that is already taxed. Hopefully, if the new sports complex comes in on the City's north side, we will be able to get revenue in to help pay for infrastructure costs that growth has brought.

If we could have found any other way to pay our bond payments, we would have taken that path. We could
