On April 4, 1957 the Village of Yorkville, located on the south bank of the Fox River, and the Village of Bristol, located on the north bank, came together to create what was then named the United City of the Village of Yorkville. In the mid 1990s the name was shortened to what is now known as the United City of Yorkville.

The people of these two towns, which had existed separately for over 100 years, decided that it was in

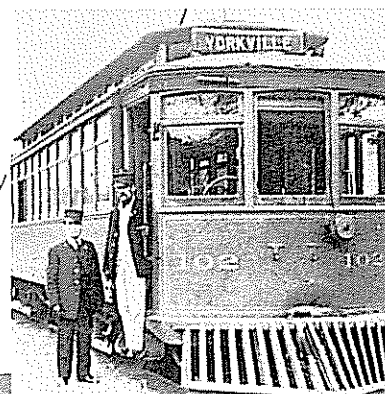

The area surrounding what is now Yorkville started a lot like other communities back in 1836. Many towns were built around railroads and prairies and were predominately farming communities. Prairies, farms and horse drawn buggies and carts pulled up and down Bridge Street. Just imagine the site—buggies, carts and horses instead of cars and utility vehicles.

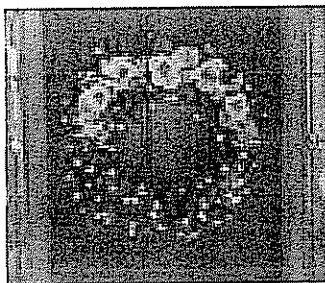

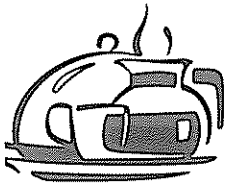

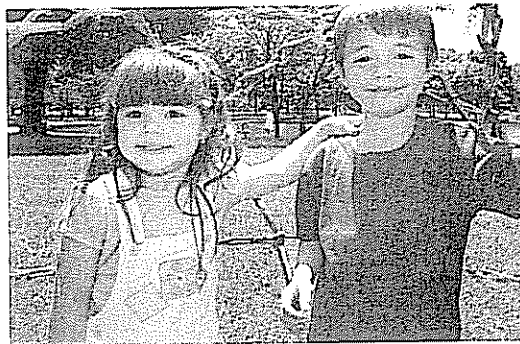

The **Illinois Humanities Council** and **Mayor Art Prochaska** honored United City of Yorkville resident **Identa Austin** as a recipient of the **Studs Terkel Humanities Service Award** at the November 28 City Council meeting. Prochaska presented Austin with an engraved medallion honoring her outstanding efforts in the humanities.

"Identa Austin has been giving back to our community for over 30 years," Prochaska said "She has donated countless hours of her time to help and guide children, teachers and the sick and elderly in the Yorkville community. It is with great honor that I and the United City of Yorkville recognize her efforts with this deserving award."

Austin was nominated because of her 30 years of service as an English teacher. As a mentor and teacher, she has guided youth in the proper and creative use of the English language. She is known for her commitment to teaching,

orchestrating, and adhering to the command of her native tongue. Throughout the years, she has made a point to use her ability to articulate, debate and relate historical and philosophical issues to improve the lives of seniors and the less fortunate. Austin is a 30-year veteran of the Illinois Retired Teachers' Association. Among her many contributions to the humanities is her 2003 donation of her family's farmland to the Illinois Retired Teachers Association. 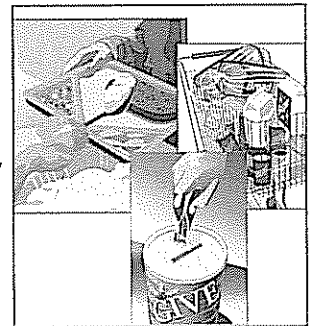
Spies also wants residents to stay tuned to the show and check the city's Web site at www.yorkville.il.us under Community Relations for programming information.

The minimum utility bill for a two-month period is \$116.95.

The minimum utility bill for senior citizens for a two-month period is \$107.05.

Grande Reserve utility billing:

The Grande Reserve utility billing will be the same charges for water, sewer and refuse. Fox Metro will be the sanitary district for Grande Reserve and will be doing their own billing from reads provided to them from our meter reads. The rates are as follows: \$5.25 minimum for 350 cu. ft. usage then \$2 per 1,000 gallons (134 cu. ft.) For example 1,000 cu. ft. usage = \$15.

A minimum utility bill from the United City of Yorkville to Grande Reserve residents will be: \$40.84. (Note: This will not include Fox Metro Sanitary District charges as they will be billing for their services)

A minimum utility bill from the United City of Yorkville to seniors 65 and older is \$30.94. (This does not include Fox Metro Sanitary charges).

The Fox Metro Sanitary District billing for filling pools and watering sod which services Grande Reserve is as follows:

- Fox Metro will adjust the bill if you have either filled a pool or watered new sod. This is not an automatic adjustment. For information you can call Fox Metro at 630.301.6881.
- New accounts will be billed at approximately \$4.50 per person, per month (approximately \$24-\$26 per month).

For more information contact Fox Metro at 630.301.6881. Please note that the Yorkville Bristol Sanitary District does not discount for pool filling or watering. The flat fee of \$76.11 is for up to 6919 cu. ft. Any usage over 6919 will be billed at \$1.10 per cu.ft.

From the Water Department

The United City of Yorkville utility bills (water, sewer maintenance, Yorkville Bristol Sanitary District, garbage bills) are sent to every residential and business unit within the city limits on or about the first of the following months: January, March, May, July, September and November.

The water meter reads are taken at the beginning of each month and billed at the end of each month. For example, reads taken at the beginning of October will be billed on October 31 for August and September water usage. If you do not receive your bill, please call City Hall at 553-4350 to obtain the balance due and due date information that you will need in order to make your payment. Please keep in mind that if you move you will need to call for a final meter read due to the lag time in the meter reading/billing process

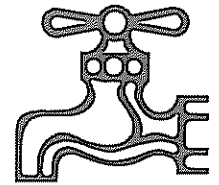
A qualified senior citizen (age 65 or older) bi-monthly refuse fee is \$1 for single family or duplex unit per utility billing cycle. Proof of age is required. For information, (630) 553-4350.

Utility billing e-pay

The Utility Billing Department is participating in an Internet payment service that is available to Yorkville residents. The E-Pay program was launched by Judy Baar Topinka's office. Payments can be made with a variety of credit cards including Visa, MasterCard, American Express, Discover and E-check. A user fee of \$3.50 per transaction is added to the payment amount for the convenience of

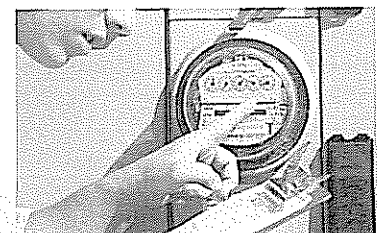
Internet service, however, this fee is not charged or collected by the city. You can visit the city Web site and follow the link, or call City Hall at (630) 553-4350 with any questions.

Direct debit available

Direct debit payment is available and it is auto-deducted from your checking or savings account on the day the bill is due. Applications are available at City Hall or on the City's Web site at www.yorkville.il.us. Completed forms can be dropped off or mailed to City Hall, 800 Game Farm Road, Yorkville, 60560.

Snowbird Policy

Residents who are absent from their residence for a period of 60 consecutive days or more qualify for the Snowbird Utility Account Policy. The City of Yorkville utility charges for water, sewer, and refuse will be waived during the resident's absence. Any resident wishing to have their water shut off at the curb box during their vacancy will be charged a \$25 shut off fee which is to be paid prior to the shutoff order being issued. The YBSD charge of \$76.11 per unit will be reduced to \$45.55 which is the debt service loan portion of the bill. It is the resident's responsibility to inform the City of their return. City, Public Works celebrates completion of water project

The United City of Yorkville held a ribbon cutting ceremony on Nov. 21 at Wells No. 3 and 4 Water Treatment plant in celebration of the completion of the city's \$20 million water system improvements. Mayor Art Prochaska and officials from Engineering Enterprises, Inc. were present to celebrate the event.

Located on Tower Lane along the city's Public Works Facility, the improvement was one of 18 construction projects that were completed over the last five years. The combination of all of the projects more than doubled the size of the Yorkville water system. The project was completed ahead of schedule, ensured radium compliance

and was completed without raising the taxes or water rates of the resident of Yorkville.

According to Mayor Art Prochaska, "I am extremely happy with the outcome of this water system project. It proves that with the right intentions and planning a project of this capacity can benefit the entire community."

With a rapidly increasing population, the City of Yorkville was faced with the task of meeting new radium compliance regulations and providing safe drinking water to meet current and projected demands. Serving as the prime engineer, Engineering Enterprises, Inc. was responsible for the planning, design, construction services and start-up assistance.

Refuse pick-up

Weekly Waste Management Refuse pick-up is as follows:

Monday: South of the river, west of Rt. 47, Bristol Bay, Greenbriar, Prairie Gardens, Rivers Edge, Sunflower Estates, and White Oak Estates.

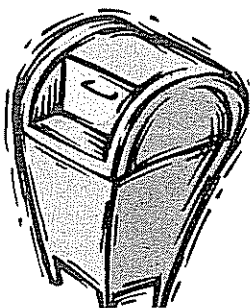
Tuesday: South of the river and east of Rt. 47, Cannonball Estates, Country Hills, Crooked Creek, Briarwood, Fox Highlands, Kylyn's, Raintree Village, Whispering Meadows, Wildwood and Windett Ridge.

Wednesday: Blackberry Creek, Grande Reserve, and Prairie Meadows

Friday: North of the river, Cimмерon Ridge, Fox Hill, Countryside Center, Heartland, Longford Lakes.

Each residence covered under the city's agreement may put out one 64-gallon Waste Management refuse cart, one 35-gallon recycle cart and one large household item on the regular pick-up date.

Please have your garbage out by 6 a.m. **Waste stickers are available for any extra items or additional refuse for \$1 at City Hall, Pride Pantry and Jewel.**



Extra recyclables do not require a sticker. Yard waste pick-up happens from April 1 through November 29. There is no yard waste pick-up from November 30 through March 30. No stickers are required on yard waste, but it must be in brown kraft bags. When holidays fall on a regular refuse pick-up day, the pick-up will be made one day later. Holidays observed during 2006 by Waste Management are as follows: New Year's Day, Memorial Day, July 4, Labor Day, Thanksgiving Day and Christmas Day. **Refuse, recycling and yard waste are collected by different trucks on different routes.** However, if you home is missed, please call Waste Management at 800-796-9696. If you have any questions, please contact City Hall at (630) 553-4350.

Explanation of YBSD charges

The United City of Yorkville bills and collects the Yorkville-Bristol Sanitary District's (YBSD) "user charges" bi-monthly. This fee includes four services the people of Yorkville pay for. The four services are water, refuse pick-up, sewer maintenance and wastewater treatment.

To meet the stricter standards mandated by the Illinois Environmental Protection Agency (IEPA) and to provide service to the area, the YBSD has borrowed \$9 million from the State of Illinois Revolving Loan Program. Loan monies pay for the expansion of the wastewater treatment plant located at 304 River St. The YBSD also has an existing debt incurred in 1991 of \$3.5 million. The dedicated source of revenue to pay these debts are part of the YBSD "user charge." The dedicated source of revenue format is a requirement of the IEPA to assure the low interest loan is paid back over a 20-year period.

The "user charges" are as follows: \$1.10 per 100 cubic feet of flow, providing that the user pay a minimum bi-monthly fee of \$76.11 of which \$45.55 is dedicated to Debt Service for the repayment of the IEPA Act Loan. The debit service fee is \$45.55 and \$30.56 is for operation and maintenance. The total is \$76.11.

Please note: If a customer uses 6,920 or more cubic feet of water, the fee would be calculated at \$1.10 per 100 cubic feet.

After hours drop box

For your convenience, there is a drop box located in front of City Hall by the entrance to the parking lot for making your utility bill payments after hours.

United City of Yorkville Mailbox Replacement Policy

The United City of Yorkville applies the following criteria for mailbox replacement.

1. Mailbox must meet City standards for installation and material.
2. Only mailboxes that are struck directly by a City vehicle or piece of equipment will be eligible for replacement. Damage caused by snow will not be eligible for replacement.

Mailbox Replacement Procedure

1. Resident must notify the Public Works department within three (3) days of the occurrence. During this time, a temporary mailbox will be placed until a determination can be made as to whether or not the City is responsible.
2. A Public Works representative will inspect the mailbox and make a determination as to whether or not the mailbox was properly installed, the material was in good condition, and if it was struck by a city vehicle.
3. If the determination is made that the City is responsible for replacement of the mailbox, the homeowner is eligible for reimbursement of up to \$75 for material to replace the mailbox. Reimbursement may be submitted to the City after the homeowner installs a new mailbox and a Public Works representative inspects it.
4. If it is determined that the City is not responsible for the damage, it will be the homeowner's responsibility to replace the mailbox following City standards.

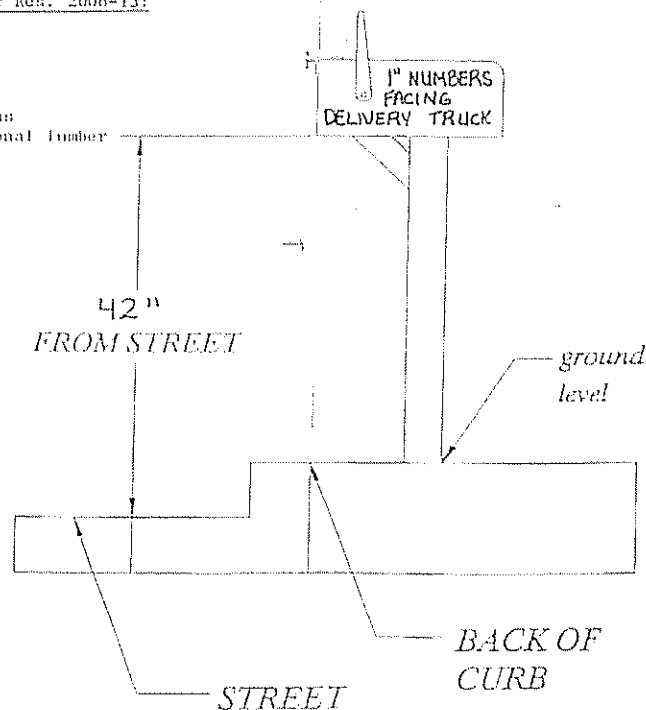

2. The front of the mailbox shall be vertically-aligned with the back of the curb.

City snow ordinances in place for winter months

Parking is not allowed on any City street in the United City of Yorkville after a snowfall of more than two inches except for emergency vehicles. In addition, parking is not allowed on any City street after a two-inch snowfall for a 24-hour period after the snowfall has ended.

Also it is unlawful to deposit snow onto the streets when shoveling driveways and sidewalks. Excess snow on the streets causes slippery conditions for both motorists and pedestrians. Please adhere to the above ordinances for the health and safety of all.

New Adventures for 2007

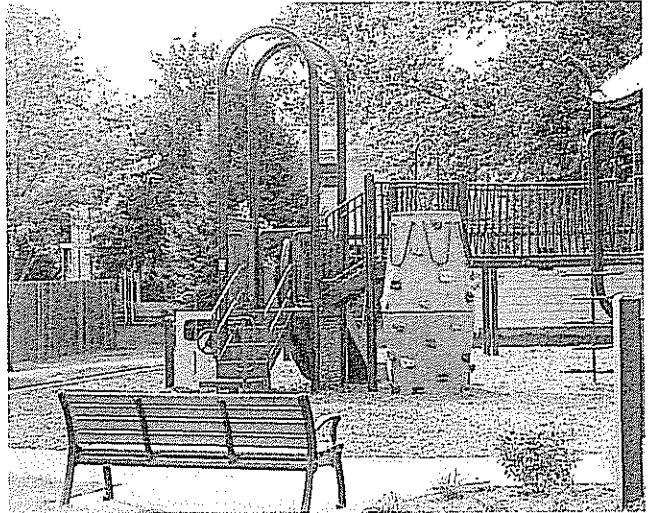
Wondering what is new in park development? Just finished this fall, Raintree Park A is a tot lot with a dinosaur theme located off of Parkside Lane. Four tot swings, an age 2-5 play structure with a tiki hut, dinosaurs to climb, and slides await the children! Discover fossil prints in the sidewalk, and more adventurous children can dig in the sandbox to find a large dinosaur fossil!

A five-acre park has been designed for **Autumn Creek Park** with a transportation theme that will guarantee fun for all ages. The design includes play structures for ages 2 to 12, a mini-skate park, sledding hill, and asphalt path. A garage-themed shelter, an age 5 to 12 play structure with overhead climbing activities, ages 2 to 5 truck and car play structures, and several swings are surrounded by an asphalt path striped road. Two working stoplights, directional signs, two crosswalks, and a railroad crossing will help kids learn the rules of the road. A parking meter, two gas pumps, and several parking spots are also included in the design. A mini-skate park will help young skateboarders learn to perfect their skills in an area designed just for them! Construction is expected to be completed in the fall of 2007.

An Open Space Lands Acquisition and Development (OSLAD) grant in the amount of \$362,000 was awarded to the City in 2006 for the development of **Whispering Meadows Park** located on Faxon Road. Near the Burlington Northern

Santa Fe Railroad and a future elementary school, this train themed park lets children be the conductors! The playground consists of a "water tower" play structure, a playground with a climbing wall, several slides, and wheelchair access onto a three-foot high deck. A challenge course provides an opportunity to test strength and agility. The tot area consists of two tot swings and a play structure with a train engine, two cars, and a caboose! A large shelter and entrance arch add to the overall train theme. A new amenity for Yorkville, a BMX track, is going to be installed at this park site. A ball field, walking trail, and native landscaping are also included as part of the design. Construction is scheduled to begin in 2007.

Prairie Meadows Park is a fire-house themed park on Hayden Road, just south of the Bristol-Kendall Fire Department Station No. 2 located on Kennedy Road. A 2007 Open Space Land Acquisition and Development (OSLAD) grant recipient in the amount of \$400,000, the eight-acre park includes a baseball field, fire truck themed tot lot, an age 5-12 play structure, swings, shelter, a perimeter walking path, and multi-purpose open space. A special feature for this park—hoses from a water tower keep the neighborhood children cool on a hot summer day! A commemorative courtyard garden at the entrance of the park, generously donated by the Bristol-Kendall Fire Department, will acknowledge the hard work and dedication of the volunteer firemen and women. The plan includes a polished stone monument and a children's safety garden with illustrative panels set into the pavement depicting fire safety advice such as "Stop, Drop, and Roll."



At **Caledonia Park** children will be able to explore their wild side with an explorer themed park on this five-acre site. Take the path or the "explorer's trail" to get to the playground, where more adventure awaits! The proposed design includes a towering structure with three decks, the highest one at 14 feet! From this height, children will be able to climb above the grass and brush and see the naturalized basin just to the south of the park. Take the slide to ground level and wrestle an alligator or peer at the landscape through real binoculars! Also included in the design is an age 2-5 play structure, swings, and a stationary safari jeep for those who like to imagine the fun of off-roading.

From the Department of Building Safety

State passes carbon monoxide detector law

Carbon monoxide is known as the "silent killer." To protect against deaths by carbon monoxide, the Illinois General Assembly passed **Illinois Public Act 094-0741** effective January 1, 2007. This Act requires that a carbon monoxide detector/alarm be operational in all existing and new residences.

What does this mean for the residents of Yorkville?

Every dwelling unit will be required to have at least one (1) approved carbon monoxide detector/alarm installed and operating within 15 feet of every room or area used for sleeping. This Act covers all types of residences, from detached single family homes, as well as every living unit in a duplex, townhouse, multiple-family (apartment), mobile homes and hotels/motels.

Section 1. Short title. This Act may be cited as the Carbon Monoxide Alarm Detector Act.

Section 5. Definitions. In this Act: "Approved carbon monoxide alarm" or "alarm" means a carbon monoxide alarm that complies with all the requirements of the rules and regulations of the Illinois State nationally recognized testing laboratory, and complies with the most recent standards of the Underwriters Laboratories or the Canadian Standard Association.

"Dwelling unit" means a room or suite of rooms used for human habitation, and includes a single family residence as well as each living unit of a multiple-family residence and each living unit in a mixed-use building.

Section 10. Carbon monoxide detector.

(a) Every dwelling unit shall be equipped with at least one approved carbon monoxide alarm in an operating condition within 15 feet of

every room used for sleeping purposes. The carbon monoxide alarm may be combined with smoke detecting devices provided that the combined unit complies with the respective provisions of the administrative code, reference standards, and departmental rules relating to both smoke detecting devices and carbon monoxide alarms and provided that the combined unit emits an alarm in a manner that clearly differentiates the hazard.

(b) Every structure that contains more than one dwelling unit shall contain at least one approved carbon monoxide alarm in operating condition within 15 feet of every room used for sleeping purposes.

(c) It is the responsibility of the owner of a structure to supply and install all required alarms. It is the responsibility of a tenant to test and to provide general maintenance for the alarms within the tenant's dwelling unit or rooming unit, and to notify the owner or the authorized agent of the owner in writing of any deficiencies that the tenant cannot correct. The owner is responsible for providing one tenant per dwelling unit with written information regarding alarm testing and maintenance.

The tenant is responsible for replacement of any required batteries in the carbon monoxide alarms in the tenant's dwelling unit, except that the owner shall ensure that the batteries are in operating condition at the time the tenant takes possession of the dwelling unit. The tenant shall provide the owner or the authorized agent of the owner with access to the dwelling unit to correct any deficiencies in the carbon monoxide alarm that have been reported in writing to the owner or the authorized agent of the owner.

(d) The carbon monoxide alarms required under this Act may be either battery powered, plug-in with battery back-up, or wired into the

structure's AC power line with
secondary battery back-up.

Section 15. Violation.

(a) Willful failure to install or maintain in operating condition any carbon monoxide alarm required by this Act is a Class B misdemeanor.

(b) Tampering with, removing, destroying, disconnecting, removing the batteries from any installed carbon monoxide alarm, except in the course of inspection, maintenance, or replacement of the alarm, is a Class A misdemeanor in the case of a first conviction and a Class 4 felony in the case of a second or subsequent conviction.

Section 20. Exemptions.

The following residential units shall not require carbon monoxide detectors:

(1) A residential unit in a building that: (i) does not rely on combustion of fossil fuel for heat, ventilation, or hot water; (ii) is not connected in any way to a garage; and (iii) is not sufficiently close to any ventilated source of carbon monoxide, as determined by the local building commissioner, to receive carbon monoxide from that source.

(2) A residential unit that is not sufficiently close to any source of carbon monoxide so as to be at risk of receiving carbon monoxide from that source, as determined by the local building commissioner.

Citizens Police Academy honors recent graduates

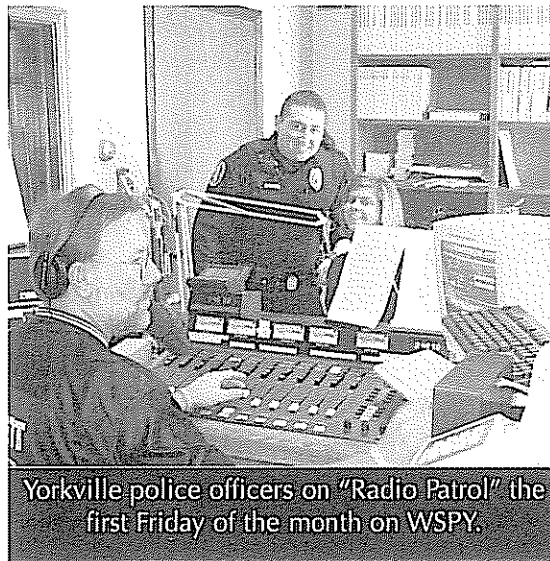

LIFELINE SCREENINGS

Life Line Screening will be offering ultrasound screenings for the prevention of stroke and vascular disease on Tuesday, Jan. 23 at the University of

Illinois Extension Office, 7775B Rt. 47, Yorkville.

Life Line Screening includes an ultrasound of the carotid arteries in the neck to determine if you are at risk for stroke. Approximately 75 percent of all strokes are linked to carotid artery blockage. Screening for the arteries of the legs are offered to check for peripheral artery disease, which is linked to heart disease. A third test is performed for detecting an aneurysm in the aortic vessel of the abdomen. A bone density screening is also offered for early detection of osteoporosis. All tests are read by a board certified vascular physician or radiologist.

These non-invasive, painless, ultrasound screenings take about 10 minutes each. Each of the three vascular tests are \$45 each. The osteoporosis screening is \$35. All three vascular screening tests can be taken for a total cost of \$109 or all four screenings for a total cost of \$129.
