The meeting was called to order at 6:00pm by Chairman Colosimo and a quorum was established.

Citizen Comments: None

Minutes for Correction/Approval: October 5, 2017

The minutes were approved as presented on a unanimous voice vote.

New Business:

1. PS 2018-01 Police Reports for July-December 2017

No comments or discussion.

2. PS 2018-02 Adjudication Reports for October-December 2017

Mr. Olson said a new law requires redaction of juvenile names. Also, Chairman Colosimo noted the numerous letters of appreciation.

3. PS 2018-03 New Liquor License Category – Banquet Halls

Staff is proposing a new category of liquor licenses specific to banquet halls with an annual fee of \$2,000. There are two such facilities slated to open, one at the future Holiday Inn and one for Riverview Diner on the south side. Alderman Funkhouser questioned the higher price, however, Mr. Olson said it is similar to hotels, golf courses, etc. This item will be tabled until another liquor license item on this agenda is discussed.

4. PS 2018-04 Code Amendment – Massage Establishment License

There are now two massage establishments in the city. The ordinance was modeled from one in Batavia and Mr. Olson reviewed the requirements. There was a brief discussion and it was questioned if windows are required. It was also noted that solicitation for business is prohibited outside the building. Mr. Olson will research the windows issue and bring the results to the Council meeting on January 23.

Old Business

2. PS 2107-19 KenCom Intergovernmental Agreements (out of sequence)

a. Tyler/New World Security and Operations Fees Intergovernmental Agreement

b. Tyler/New World Licensing and Maintenance Fees Intergovernmental Agreement

Oswego Police Chief Burgner presented a report on these agreements. In 2004 Yorkville and Oswego (and later Plano) began partnering with Kendall County. The reporting systems (New World) and the CAD did not work together since they had different software. The current CAD system is 20 years old and is being replaced.

The CAD project is being undertaken by the County, and the municipalities and Fire Department wish to join. It was found the Tyler New World system is the best. Montgomery is also now interested and was able to contribute some of the software to reduce costs. The committee in charge of this project put together all necessary documents for joint operations and licensing agreements including shared costs, maintenance, etc. for all entities. Chief Burgner explained the components of each of the agreements. All participating agencies will have access to the other's records.

The fee amounts were then discussed. A current maintenance fee that the city pays, was reviewed and Alderman Funkhouser asked staff to ensure the city is not paying double on the RMS agreement or the maintenance fee. This moves to the regular agenda of the next Council meeting.

Old Business:

3. PS 2018-03 New Liquor License Category--Banquet Halls (from New Business)

1. PS 2017-18 Liquor License Application and Fee Review

Chairman Colosimo indicated he was not in favor of the increase of fees simply to keep pace with other towns. However, after reviewing the memo, he is less opposed. Alderman Plocher said the fees were justified. Alderman Funkhouser said he was not in total agreement that fees should be tied to potential calls for service, but staff time spent justified the increases. Alderman Funkhouser suggested a FAQ online to answer applicant questions to help reduce staff time. He also suggested a new liquor license class for the banquet halls.

There has been no fee increase in 22 years said Mr. Colosimo. All were OK with the late penalty fee increase and the \$250 increase in application fees. Mr. Colosimo suggested a banquet hall application fee of \$1750.

The current late fee for liquor license renewals is \$100 with a 14 day deadline. It was noted that renewal notices are sent on January 1. After much discussion, the following fees were recommended for late applications:

Apply before April 1:	no late fee
Apply April 1 to April 21:	\$100 late fee
Apply April 22 or after:	\$750 late fee

Additional Business

Traffic issues at Rt. 47 and Galena Rd. were discussed. Alderman Funkhouser suggested the city reach out to the County and also ask the State to revise the 5 year plan to move up the intersection improvements. Mr. Olson said he spoke with IDOT engineers and they are looking at a full expansion in a multi-year program. IDOT officials are also looking at short term improvements. Letters of support from the city and county and a letter of resolution to the State representatives for at least intersection work were recommended. The committee concurred.

There was no further business and the meeting was adjourned at 7:07pm.

Summary

Consideration of an amendment to the liquor code for catering licenses.

Background

In 2011, the catering license section of the liquor code was amended to allow a business with an A-1 liquor license located in a B-2 business zoning district to sell alcohol during a live indoor entertainment event in the same zoning district, at which an admission fee is charged for the event. The proposed amendment would allow for the catering license to also be used during the showing of a movie in a theatre in addition to live indoor entertainment events.

The second proposed amendment to the catering license class would remove the language that allowed for catering liquor licenses to be issued at the Meadowhawk Lodge at Hoover Forest Preserve. The portion of land where Meadowhawk Lodge is situated was de-annexed by the city via Ordinance No. 2014-02. This portion of the code amendment is a clean-up of the code.

Recommendation

Staff recommends approval of the attached ordinance.

3-3-4 Classes of Licenses

CA - Catering. Authorizes the licensee to sell alcoholic liquor in connection with the operation of:

a. A catering business with its business license location within the city to sell to the general public alcoholic liquor in its original packages only, for consumption at a private party in the city when the food for said party is prepared by the licensee, or

b. An existing class A-1 licensee with its existing license location in the city's B-2 business zoning district to sell alcoholic liquor during a live indoor entertainment event or the showing of a movie in a theatre in the same zoning district, at which an admission fee is charged for that event, by service not in its original container, and with or without food service.

~~c. A catering business with no business license location within the city to serve alcoholic liquor for consumption only on the premises of the Hoover Forest Preserve where food is catered by the licensee and when the alcoholic liquor and food are served by the licensee. The event shall not be open to the public nor shall there be an admission fee charged. The sale of alcoholic liquor shall be incidental to the food service. The catering business must furnish a copy of both their state of Illinois and a municipal catering liquor license. The background check may be waived at the discretion of the chief of police if it can be confirmed that the issuing municipality performed proper background checks on the licensee and the manager. The licensee shall be required to comply with the city's dramshop insurance requirements. The license fee shall be seventy five dollars (\$75.00) per day or five hundred dollars (\$500.00) per year.~~

~~All food and beverage sales made by the licensee shall be taxed as if made at the licensee's location of its business or existing liquor license.~~

WHEREAS, pursuant to section 5/4-1 of the Liquor Control Act of 1934, as amended, (235 ILCS 5/1-1 et seq.) the corporate authorities have the power to determine the number, kind and classification of liquor licenses and the regulations for the sale of alcoholic beverages; and in addition pursuant to its powers to protect the public’s health, welfare and safety this Ordinance is hereby adopted.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the United City of Yorkville, Kendall County, Illinois, as follows:

Section 1: That Title 3, Chapter 3, Section 3-3-4A4, “CA - Catering”, subparagraph b. of the Yorkville City Code, as amended, be and is hereby amended to read as follows:

“b. An existing Class A-1 licensee with its existing license location in the City’s B-2 business zoning district to sell alcoholic liquor during a live indoor entertainment event or the showing of a movie in a theatre in the same zoning district, at which an admission fee is charged for that event, by service not in its original container, and with or without food service.”

Section 2: That Title 3, Chapter 3, Section 3-3-4A4, “CA – Catering”, subparagraph c. and the sentence following, of the Yorkville City Code be and are hereby repealed.

Section 3: This Ordinance shall be in full force and effect upon its passage, approval, and publication as provided by law.

Summary

Proposed amendment to the liquor code deleting the requirement for a license fee deposit for liquor license applications.

Background

The liquor code contains a provision that all new liquor applications, when submitted, must be accompanied by a non-refundable application fee plus a deposit equal to the license fee payable up to the next renewal date. The non-refundable application fee was recently increased by ordinance to \$350.00. With this increased application fee, staff is recommending the removal of the requirement for a license fee deposit.

Recommendation

Staff recommends approval of the attached ordinance.

3-3-3: APPLICATION FOR LICENSE AND RENEWAL:

The local liquor control commissioner shall grant liquor licenses in accordance with the provisions of the laws of the state of Illinois and provisions of this chapter. Any person desiring a license under this chapter shall make application to the local liquor control commissioner to be filed with the city clerk who shall provide a blank form for that purpose in such form as may be designated by the local liquor control commissioner. The application shall be sworn to by the applicant, if an individual, and by at least two (2) members of any partnership applying for such license. Applications by corporations shall be subscribed and sworn to by the president and attested by the secretary thereof. Reference: Opioid Law Suit Discussion

Currently there is a large class action type lawsuit that has been filed seeking compensation from the opioid manufacturers. This law suit is related to the nationwide opioid epidemic/addiction problem. Several neighboring municipalities and counties have been approached by attorney's to take part in this action. Both Kendall County and Oswego have had presentations at their board meetings in the last few months. Last month I was approached by Attorney Kathleen Chavez from Foote, Mielke, Chavez, and O'Neil LLC, she has requested that we look into joining this lawsuit using her law firm. As of today no other Attorney or law firm has made contact with me about this.

The Yorkville Police Department has been impacted by the opioid problem. Most of the heroin users that we come in contact with started their opioid addiction with prescription pain pills. Unfortunately when the pain pills run out the only source to fill the addiction is illegal heroin. All of our Officer's have been trained in the use of Narcan (anti-overdose drug). We have administered doses of Narcan on 4 different occasions, 3 of them were successful, and 1 was not. We have also responded to numerous overdoses where the victim was deceased or where EMS or neighboring jurisdictions have administered Narcan.

The majority of the crimes committed in Yorkville such as thefts, burglaries, domestic disputes, crimes against persons, and so on are involving an increasing number of opioid addicts. It is very hard to put a direct cost to our response to this problem, but

opioid addiction is without a doubt a large and growing problem. The Cooperative Police Assistance Team (CPAT) has served several search warrants in our town and our surrounding areas for possession of opioids. At this time the problem is increasing, despite the national efforts to stop it. If this law suit is successful we will receive funds for training, prevention, and enforcement efforts.

I recommend that we look into joining this law suit.

County Board endorses joining multi-county opioid suit

Kendall County Board members endorsed joining a multi-county lawsuit against opioid manufacturers during a recent committee meeting.

Board Chairman Scott Gryder, Vice Chairman Lynn Cullick and board members Bob Davidson, Matthew Prochaska, Matt Kellogg, Audra Hendrix and Judy Gilmour all agreed that Kendall County should move forward with joining the lawsuit at the March 15 Committee of the Whole meeting, although there was no formal vote taken. Tony Giles, John Purcell and Elizabeth Flowers were absent from the meeting.

The board is expected to vote on formally joining the lawsuit at its April 3 meeting.

Attorneys with the firm of Meyers and Flowers, which has offices in St. Charles and Chicago, attended the March 15 meeting and a board meeting in February to discuss joining the group of suburban Chicago counties that are also suing. Meyers and Flowers is representing the other counties.

During the March 15 discussion, Davidson asked attorney Michael Lenert of the Meyers and Flowers firm what the lawsuit would cost the county. Lenert said the representation is based on a contingent arrangement, so it would not cost the county anything except for a portion of the settlement money if the counties are victorious in the lawsuit.

"There is no risk to any of your taxpayers," Lenert said. "If we were to litigate this case hypothetically for five years and come back to you and say we're really sorry, we fought the good fight but unfortunately we were unable to recover any money for Kendall County, the county would not owe our law firm any money for the costs that we've undertaken to litigate this case or any attorney's fees."

Lenert said it would be up to the county as to how to distribute any funds it might receive from a settlement.

Lenert said the cost of opioid addiction runs in the billions of dollars.

"This epidemic, it's a real problem," he said. "The Centers for Disease Control and Prevention estimated that the annual cost nationwide for opioid addiction is over \$78 billion. Most of us know people that have had issues with opioid addiction. It's affected every county across the United States. ... I think it's clear that Kendall County has had to face this issue, has paid a lot

of money to try to address this issue, and we hope to work with Kendall County to try to abate this problem.”

Gryder mentioned a recent panel discussion hosted by the county’s Health Department that involved various members of the law enforcement, mental health, and judicial communities.

“A couple numbers stuck out in my head from [the panel]: one was 13, and the other was 115,” he said. “There were 13 deaths in Kendall County last year that were the direct result of opioid overdoses, and those are just the ones that occurred in our county. We’re not able to track the ones that maybe the overdose occurred in our county and then they passed away at one of the hospitals that surround our county. So the number could be much higher. The 115 was ... 115 a day across the nation are dying [of opioid overdoses]. It really sticks out in your mind that it’s something that’s preventable and shouldn’t be occurring.”

Kellogg asked how the damages would be calculated for each county. Lenert said they have experts working with all of the counties to determine a “damage profile” on how much each county is impacted by the issue.

Weis said the epidemic has affected the county financially, not to mention the impact on local families.

“We look at everything from a typical fire and EMS response to treatment at a medical provider to rehab facilities to the impact in the court system if they’re charged with a crime to dealing with... penitentiary time – these are just, off the top of my head, costs that are associated with [opioid abuse],” he said. “That’s just the parts that we see. The impact on families, the impact on society, we’re seeing this across the board as well.”

Board member Audra Hendrix said she heard a PSA that stated the number of people dying from opioid overdoses per day was equal to a fatal plane crash every day.

Weis said that while he doesn’t think joining the lawsuit will solve the opioid problem in Kendall County, it could help offset some of the costs to the county.

“You don’t have to [join] the suit. I’m not saying it’s going to solve the problem by filing this suit, I’m not here to say this is the solution to the opiate problem, [but] it is one avenue to address an ever-growing problem,” he said. “It could be financially beneficial to the county to recoup some of the costs that’s incurred by doing this – there’s a cost to have people respond to these things. The people that make the product are the ones who should be held responsible. Whether [the board members] choose to or not, it’s up to you.”

Referring to Hendrix’s plane crash analogy, Weis said, “If planes were falling out of the sky at a rate of that many per day, they would do something to the manufacturer of the airplane to

say, look, you can't continue to make a product that kills that many people per day without fixing the problem."

Following the discussion, board members discussed whether they wanted to move forward with the suit. All did, although Davidson and Kellogg said they would like to have on record where the money will go if the county receives any from the lawsuit.

"I'm for filing suit immediately," Hendrix said.
