VERIFIED OBJECTOR'S PETITION

NOW COMES Donald T. Vandermyde, hereinafter referred to as the "Objector," and respectfully represents that Objector resides at 2341 Iroquois Ln, Yorkville, IL 60560, in the 3rd Ward of the United City of Yorkville, State of Illinois; that Objector is a duly qualified, registered, and legal voter at such address; that Objector's interest in filing the following objections is that of a citizen desirous of seeing to it that the laws governing the filling of nomination papers for Independent nomination/election to the office of Alderman from the 3rd Ward of the United City of Yorkville in the State of Illinois are properly complied with and that only qualified candidates have their names appear on the ballot as candidates for the said office; and therefore your Objector makes the following objections to the nomination papers of Malanda Griffin as an independent candidate for nomination/election of to the office of Alderman from the 3rd Ward of the United City of Yorkville of the State of Illinois, and files the same herewith, and states that the said nomination papers are insufficient in law and in fact for the following reasons:

1. Your Objector contends that the Candidate failed to demonstrate any attempt to sufficiently file the requisite and mandatory Statement of Economic Interests according to state Election Code and Illinois Governmental Ethics Act:

Article XIII Section 2 of the Illinois Constitution provides:

"SECTION 2. STATEMENT OF ECONOMIC INTERESTS

All candidates for or holders of state offices and all members of a Commission or Board created by this Constitution shall file a verified statement of their economic interests, as provided by law. The General Assembly by law may impose a similar requirement upon candidates for, or holders of, offices in units of local government and school districts."

Your Objector states that the laws pertaining to the securing of ballot access require that certain requirements be met as established by law. Filings made contrary to such requirements must be voided, being in violation of the statutes in such cases made and provided. One such legal requirement mandates the filing by the Candidate of the receipt from the "Statement of Economic Interest" filed pursuant to the Illinois Governmental Ethics Act, which receipt and statement must be made "in relation to his candidacy." *See Jones v. Municipal Officers Electoral Board*, 112 Ill.App.3d 926, 446 N.E.2d 256, 68 Ill. Dec. 522 (1st Dist. 1983).

Section 10-5 of the Election Code provides:

"Nomination papers filed under this Section are not valid if the candidate named therein fails to file a statement of economic interests as required by the Illinois Governmental Ethics Act in relation to his candidacy with the appropriate officer by the end of the period for the filing of nomination papers unless he has filed a statement of economic interests in relation to the same governmental unit with that officer during the same calendar year as the year in which such nomination papers were filed. If the nomination papers of any candidate and the statement of economic interest of that candidate are not required to be filed with the same officer, the candidate must file with the officer with whom the nomination papers are filed a receipt from the officer with whom the statement of economic interests is filed showing the date on which such statement was filed. Such receipt shall be so filed not later than the last day on which nomination papers may be filed. 10 ILCS 5/10-5 (West 2010).

Section 4A-106 of the Ethics Act provides:

The statements of economic interests required of persons listed in items (g),[1] (h), (i), (k), and (o) of Section 4A-101 shall be filed with the county clerk of the county

in which the principal office of the unit of local government with which the person is associated is located. 5 ILCS 420/4A-106 (West 2010).

The requirements of the Election Code are mandatory. *Kellogg v. Cook County Illinois Officers Electoral Board*, 347 Ill.App.3d 666, 670, 283 Ill. Dec. 320, 807 N.E.2d 1161 (2004); *Welch v. Johnson*, 47 Ill. 2d 40, 167 Ill. Dec. 989, 588 N.E.2d 1119 (1992).

The Nominating Papers of Malanda Griffin do not contain a receipt from the Kendall County Clerk for a statement of economic interests. The "KC Voter Registration" stamp on the statement of economic interest is not of the requisite office for compliance with the mandatory requirements. The nomination papers are, therefore, not in compliance with the statutes in such cases made and provided and should be determined to be void. This wholly fails to comply with the mandatory provision of the Election Code, jeopardizes the integrity of the electoral process, and is a nullity.

The Illinois Governmental Ethics Act (the Ethics Act) requires that candidates for public office file a "Statement of Economic Interests." 5 ILCS 420/4A-103, 4A-104 (West 2010). See also 10 ILCS 5/10-5 (West 2010) (a candidate must submit the "Statement of Economic Interests" form "as required" by the Illinois Governmental Ethics Act).

The filing of a statement of economic interests is to "to reveal conflicts of interest between the public trust and private gain by requiring disclosure of financial interests related to public employment." Miceli v. Lavelle, 114 Ill. App. 3d 311, 313 (1983).

The Candidate in fact failed to file any statement of economic interests with the county. This failure again wholly fails to comply with the mandatory provision of the Election Code, jeopardizes the integrity of the electoral process, and is a nullity. *See Cortez v. Municipal Officers Electoral Board*, 2013 IL App (1st) 130442

2. Your Objector contends that the Candidate failed to describe the office of Alderman/person Ward 3, as required by section 4A-104 of the Ethics Act but also by section 10-5 of the Election Code, which provides that "[n]omination papers * * * are not valid if the candidate named therein fails to file a statement of economic interests * * * in relation to his candidacy * * *." (Emphasis added.) (Ill. Rev. Stat. 1981, ch. 46, par. 10-5(3).)

The public has a right to know of any financial dealings between a candidate and the unit of government in which he seeks office. The provisions of the Election Code are designed to facilitate that right. The repetition of "in relation to his candidacy" in the Election Code requires that candidates comply with section 4A-104, however, the Courts determined the requirement to be mandatory and not directory by its duplicity. See *Jones v. Municipal Officers Electoral Board* (1983), 112 Ill. App. 3d.926

3. Your Objector contends that the Candidate frustrated the nomination process with inconsistencies in the nomination papers. Here, Griffin stated the office sought as "Alderperson" in her Statement of Candidacy and as "Alderperson/Ward 3" on her petition signature sheets (and other documents). The United City of Yorkville has four Aldermanic wards with all four having elections in the Consolidated Election on April 4, 2023.

The Candidate further frustrated the nomination process by using a Statement of Candidacy Nonpartisan and Independent Candidate Petition forms. The election Code (10 ILCS 5/10-3) (Ch. 46, par. 10-3 & 10-3.1) and (10 ILCS 5/2A-1.2(c)(1)) include specific elections, form of government and requirements for the use of each type of document. Here the use of a Statement of Candidacy Nonpartisan form creates confusion and irregularities.

The nomination papers thus contain inherent inconsistencies that give rise to confusion. "If nominating papers describe only one possible [office], then there is no basis for confusion." Pascente v. County Officers Electoral Board of the County of Cook, 373 Ill. App. 3d 871,874 (2007). Where the papers refer to more than one office, there is a basis for confusion. See, e.g., Heabler v. Municipal Officers Elec. Bd., 338 Ill. App. 3d 1059, 1062-63 (2003)

Section 10-5 of the Code provides, in pertinent part: "certificate of nomination or nomination papers *** must include a statement of candidacy for each of the candidates named therein ***. Each such statement shall set out the address of such candidate, the office for which he is a candidate, shall state that the candidate is qualified for the office specified *** [,] shall request that the candidate's name be placed upon the official ballot and shall be subscribed and sworn to by such candidate before some officer authorized to take acknowledgments of deeds in this State *** [.]" 10 ILCS 5/10-5 (West 2020).

The statutory requirement governing statements of candidacy and the accompanying oath are mandatory requirements. *Cinkus*, 228 Ill. 2d at 219. Thus, "[i]f a candidate's statement of candidacy does not substantially comply with statutory requirements, the candidate is not entitled to have his or her name appear on the ballot." *Goodman v. Ward*, 241 Ill. 2d 398, 409 (2011).

WHEREFORE, your Objector prays that the purported nomination papers of Malanda Griffin for Independent nomination/election to the office of Alderman from the 3rd Ward of the United City of Yorkville in the State of Illinois be declared by this Honorable Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois and that the Candidate's name be stricken and that this Honorable Electoral Board enter its decision declaring that the name of Malanda Griffin for Independent nomination/election to the office of Alderman from the 3rd Ward of the United City of Yorkville in the State of Illinois BE NOT PRINTED on the OFFICIAL BALLOT for at the Consolidated Election to be held on April 4, 2023.
