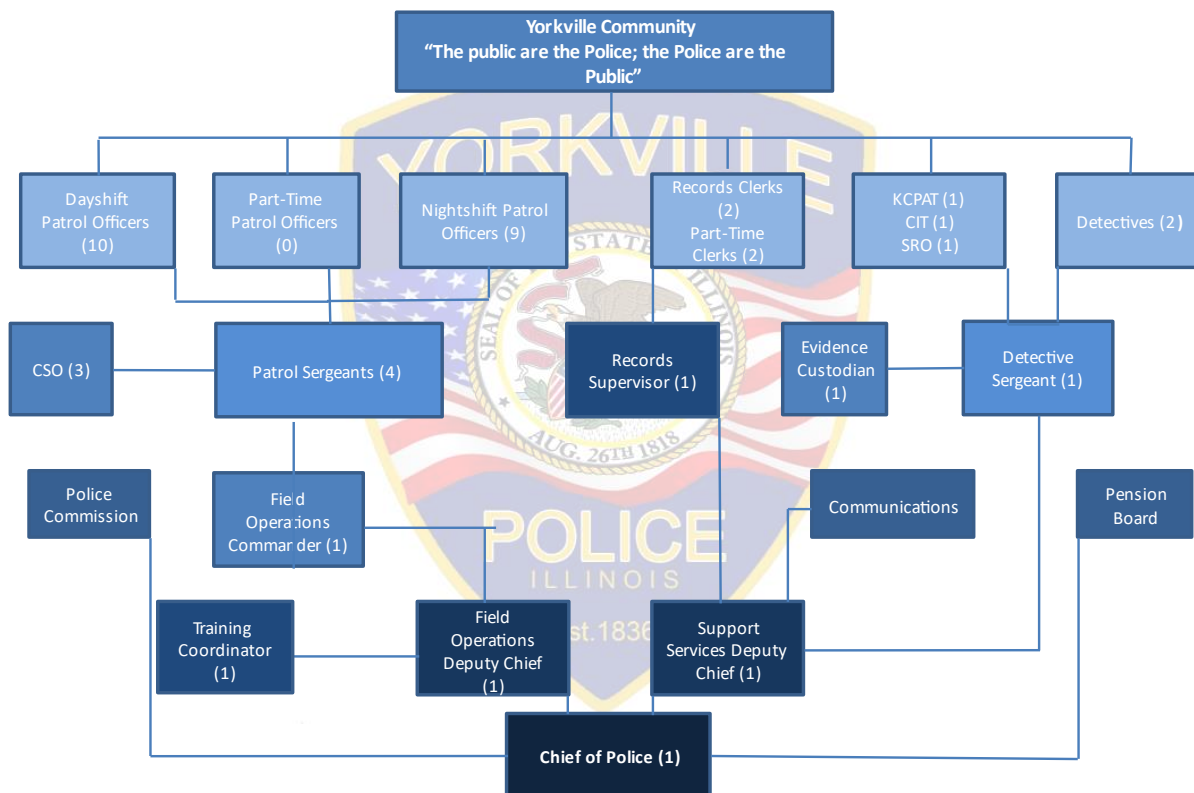

COMMUNITY POLICING INITIATIVES

Community Information

Facebook Post (12/5/24): ‘Tis the season... for scammers.

Have you received unsolicited mobile text messages with an unfamiliar or strange web link that indicates a USPS delivery requires a response from you? If you never signed up for a USPS tracking request for a specific package, then don't click the link! This type of text message is a scam called smishing.

Smishing is a form of phishing that involves a text message or phone number. Victims will typically receive a deceptive text message that is intended to lure the recipient into providing their personal or financial information. These scammers often attempt to disguise themselves as a government agency, bank, or other company to lend legitimacy to their claims. USPS utilizes the 5-digit short codes to send and receive SMS to and from mobile phones.

The criminals want to receive personally identifiable information (PII) about the victim such as: account usernames and passwords, Social Security number, date of birth, credit and debit card numbers, personal identification numbers (PINs), or other sensitive information. This information is used to carry out other crimes, such as financial fraud.

The Postal Service offers free tools to track specific packages, but customers are required to either register online, or initiate a text message, and provide a tracking number. USPS does not charge for these services! USPS will not send customers text messages or e-mails without a customer first requesting the service with a tracking number, and it will NOT contain a link. So, if you did not initiate the tracking request for a specific package directly from USPS and it contains a link: don't click the link!



Facebook Post (12/11/24): Yorkville Police Department will be conducting speed enforcement details along Route 47 in our downtown business district starting December 10th and continuing through the winter months. During this holiday season, shopping and traveling to visit friends and family increases the number of vehicles on our roadways. With increased traffic and winter weather returning to our area, it is a crucial time to prioritize safety on our roads.

Our recent traffic studies have revealed a large number of speeding vehicles in our downtown district. It is always important to be mindful of your speed, especially in an area with several businesses and frequent pedestrian traffic. It is the goal of these details to ensure safe travel for everyone while also increasing compliance with speed-related laws.

Yorkville Police Department encourages everyone to drive safely and enjoy their holiday season.



Facebook Post (12/16/24): Increased police presence in the area of VanEmmon and Mill Street downtown Yorkville. Call came in as a person with a gunshot wound. Responding officers still investigating. More information to follow.

UPDATE (8:00P.M): Officers remain on the scene conducting an investigation. The victim has been transported to the hospital with a gunshot wound. At this time, there is no indication of foul play or that a criminal act has occurred. We kindly ask the public to avoid the area, as it remains an active scene.

Facebook Post (12/17/24): Additional charges filed from June human trafficking investigation. On Friday December 13th, 2024 Yorkville Police investigations unit arrested Albert G. Pintoy Jr. (m/w 53yoa 12000 block Red Clover Ln. Plainfield, IL) on charges of traveling to meet a minor (class 3 felony) stemming from a cooperative two-day human trafficking investigation conducted in June of this year. Investigative efforts discovered digital evidence of Pintoy Jr. seeking to engage in commercial sex acts on June 27, 2024 in Yorkville, IL. Pintoy Jr. was taken into custody without incident and transported to the Kendall County Jail.

Charges are not proof of guilt. The defendant listed in this release is presumed innocent and is entitled to a fair trial, at which it is the burden of the State to prove guilt beyond a reasonable doubt. ORIGINAL RELEASE (JUNE 28, 2024)

ILLINOIS STATE POLICE LEADS HUMAN TRAFFICKING ENFORCEMENT OPERATION

YORKVILLE – The Illinois State Police (ISP) Division of Criminal Investigation Trafficking Enforcement Bureau arrested three individuals during a two-day human trafficking enforcement operation in the Yorkville area of Kendall County on June 26-27, 2024. The operation focused on identifying individuals seeking to engage in commercial sex acts.

As a result of the operation, the following individuals were arrested and charged:

- Nathanael Beckley (34) of Bolingbrook, IL – Traveling to Meet a Child (Class 3 Felony)
- Salvo Campagna (39) of Plano, IL – Indecent Solicitation a Child (Class 3 Felony), Traveling to Meet a Child (Class 3 Felony), and Solicitation to Meet a Child (Class 4 Felony)
- Marcus Ramirez (26) of Sandwich, IL – Indecent Solicitation a Child (Class 3 Felony), Traveling to Meet a Child (Class 3 Felony), and Solicitation to Meet a Child (Class 4 Felony)

This operation was part of a multifaceted approach by ISP aimed at stopping human trafficking in Illinois. ISP special agents and SWAT officers partnered with the Kendall County Police Assistance Team, Kendall County Sheriff's Office, Yorkville Police Department, DuPage Metropolitan Enforcement Group, Will County Police Assistance Team, and North Central Narcotics Task Force, for the operation. The Kendall County State's Attorney's Office also provided support for the operation.

Human trafficking is the use of force, fraud, or coercion to compel a person into commercial sex acts, labor, or services against their will. ISP continues its multifaceted approach toward protecting those most vulnerable with its ongoing statewide human trafficking enforcement operations. Facebook Post (12/19/24): On Thursday, December 19, 2024, the Yorkville Police Department arrested Trevor Minogue, (25-year-old male, 2600 block of Fairfax Way Yorkville, IL) on charges of traveling to meet a minor (class 3 felony – 2 counts), indecent solicitation of a child (class 3 felony – 2 counts), and aggravated criminal sexual abuse (class 2 felony – 2 counts). Charges against Minogue were related to two ongoing investigations.

The first investigation commenced on December 12, 2024, following a delayed report of a criminal sexual assault that occurred on August 30, 2024, on the 700 block of East Veterans Parkway between Minogue and a minor. During the initial report, Yorkville Police learned that Minogue was employed as a substitute teacher with Yorkville Community Unit School District 115.

Upon contact with Y115, it was determined that Minogue had recently been employed as a substitute teacher with limited interaction with students. He had not been in a school setting since December 9, 2024. As a precautionary measure, Y115 ensured that Minogue would not interact with students during the investigation.

Subsequently, on Thursday, December 19, the Yorkville Police Investigations Unit made contact with Minogue at the 8000 block of Route 71 during an additional investigation. During this interaction, Minogue was arrested on charges related to traveling to meet a minor. The arrest was made without incident, and Minogue was transported to the Kendall County Jail.

Currently Yorkville Police have no indication of additional victims, however, this is an ongoing investigation and will be updated should additional evidence be discovered. Minogue will remain in custody until his scheduled court appearance on December 20, 2024.

Facebook Post (12/30/24): * Route 47 Downtown Railroad Crossing *****

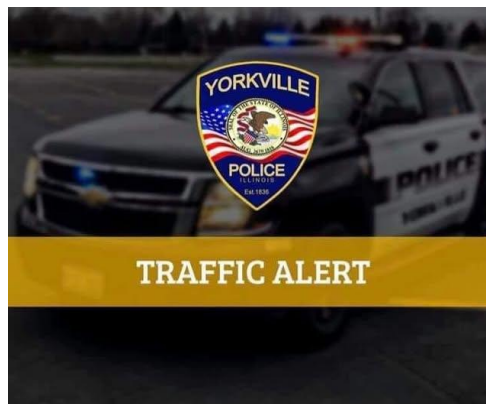

UPDATE 12/30/24 1:18pm - The roadway is now open. Please be patient as traffic dissipates.

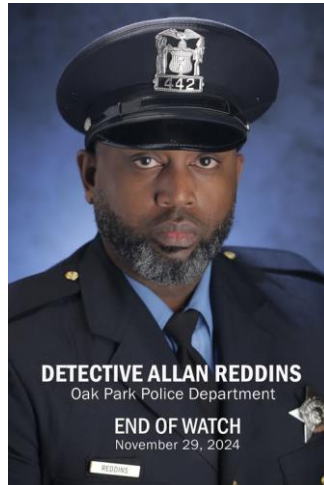

TRAFFIC COMPLAINT / ENFORCEMENT INFORMATION

In **January through December 2024**, the Yorkville Police Department had received traffic concerns for various locations in town. These concerns were established through both citizen concerns and areas of concern for the department. All citizen concerns were tracked for potential issues. In some cases to verify that the concerns needed to be further addressed, (5) five years of crash data was researched. In addition, these locations were further researched by utilizing the department's speed signs. These speed signs were able to collect traffic data related to traffic counts, speed data, and various times of day of violations. In addition, the department also relied upon its partnership with EEI.

DETECTIVE SQUAD

On December 19th, 2024, the Investigations Unit took Trevor J. Minogue (25 years old) into custody stemming from an active criminal sexual abuse investigation. That case was reported to the police department on December 12th, 2024. Minogue, who was a substitute teacher for the Yorkville School District, was accused of meeting and engaging in a sexual conduct with a juvenile. While investigating that case, investigators made contact with Minogue via a third-party website while posing to be a minor. Minogue ultimately agreed to meet investigators (thinking he was a minor) in order to engage in a sexual act. Minogue was taken into custody at the meeting location and ultimately charged with Traveling to Meet a Minor (2 counts), Indecent Solicitation of a Minor (2 counts), and Aggravated Criminal Sexual Abuse (2 counts). Minogue remains in custody and the investigation is ongoing.

On December 12th, 2024, Detective Johnson secured an arrest warrant for Albert G. Pintoy (53 years old) for Traveling to Meet a Minor (1 count). This warrant was issued due to an investigation that began in June of 2024 when the Investigations Unit was involved in a multi-jurisdictional investigation involving the Illinois State Police and the Kendall County Sheriff's Office. That investigation was focused on Human Trafficking. Pintoy's arrest stemmed from that incident. Pintoy was taken into custody at his home in Plainfield, Illinois.
